Announced by President Obama at the Presidential Summit on Entrepreneurship in May, this groundbreaking US State Department program is designed as a professional exchange experience for 30 leading entrepreneurs from 30 different countries. These delegates will engage in a three-week program of educational experiences, peer-to-peer sharing, cultural engagement, mentoring and long-term relationship-building with each other and with leading American entrepreneurs, business executives, government officials and leaders from civil society.

The initiative is a partnership between the US State Department and two private-sector organizations active in promoting cross-cultural understanding and entrepreneurship: **Business for Diplomatic Action** (BDA) and the **Entrepreneurs' Organization** (EO).

Program Goals and Objectives

- » To create a dynamic learning environment and peerto-peer networking opportunities for sharing innovative entrepreneurial business strategies and best practices.
- » To explore the variety of ways by which successful entrepreneurs and innovators serve a wide range of market niches.
- » To expand the understanding of how partnerships can link capital, business development services and market access— thus enabling entrepreneurs to build high-growth and high-impact ventures.
- » To build lasting relationships that will continue to encourage and facilitate the sharing of best practices and experiences on an ongoing basis after the program's completion.
- » **To introduce** how the US approaches social entrepreneurship.

The Program Includes

- A proven educational curriculum delivered through EO's Accelerator program in four full-day segments. This educational component helps entrepreneurs build their businesses by enhancing their skill sets in strategy, human resources, sales, marketing and finance.
- » Mentorship and peer-to-peer connections between the delegates and many leading American entrepreneurs of similar industry, life stage and entrepreneurial experience.
- Professional encounters enabling the delegates to engage with accomplished U.S. entrepreneurs and business leaders, high-level government officials and other business development stakeholders.
- » Joint events with local EO chapters and BDA supporters, including more than 100 EO members in each city. These events will create additional opportunities for networking, cultural exchange and business experience sharing.

Through its International Development and Exchange Programs, World Learning undertakes community-driven projects that bridge cultures and transform lives.
